

**ARTICLES OF INCORPORATION OF
PINER HIGH ATHLETIC BOOSTERS, INC.**

ARTICLE I.

The name of the corporation is **Piner High Athletic Boosters, Inc.** The corporation's registered office is located at 1700 Fulton Road, Santa Rosa, CA 95403

ARTICLE II.

- A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.
- B. The specific purpose of this corporation is to further the cause of all student athletic programs and activities of Piner High School. The purpose is to aid the Piner High School athletics and activities financially through fundraising and promoting school and community interest in the activities of the students at Piner High School.
- C. This corporation shall be a non-profit organization and all funds and monies obtained shall be used for athletics, student activities, and enhancement of the school and to ensure operation of the club.

ARTICLE IV.

- A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- C. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon dissolution or winding up of the corporation, it's assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to Piner High athletics, a non-profit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE V.

To the furthest extent permitted under California law no member, officer or director of this corporation shall be personally liable for the debts or obligations of this corporation. Nor to the furthest extent permitted under California law shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.
